1. Nominations for members of the MAHPC for the term 2023-2026.

The first MAHPC members for the term 2020-2023 will expire on 30 June 2023. As per the requirements of Section 5 (1) (c) of the Act 774 the subsequent Council must be appointed by the Minister of Health from each profession from among registered practitioners in the public or private sector or institutions of higher education. In accordance with these provisions, any registered practitioner who meets the conditions as stated can submit nominations as Council Members for each profession in the Second Schedule (2022) on and before 10 May 2023.
